THIS IS TWICE THE NUMBER OF FAMILIES - WHO WON'T HAVE TO SLEEP, EAT OR LIVE ON A COLD, HARD FLOOR - THAN WE SERVED JUST FIVE YEARS AGO. 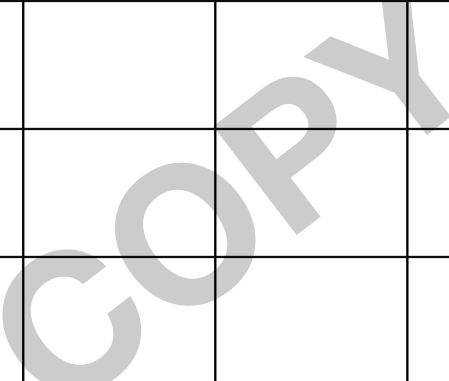
